# **BOARD NOMINEE INTERVIEWS**

#### Rick Dalessandro

I'm not really sure how long I have been a member of MOTC, probably 8 years and have served on the Board for 6 of those years. I currently have two terrific yellow labs, Darby (10 years old) and Callie (2 years old). Darby is my once in a life time dog. She's nearly perfect, sweet and eager to learn and in her whole life she has chewed up a shoestring. I think she has 23 titles. Her crowning achievement is her UDX2 and OM1 but she also has titles in Rally, Dock Diving, Fast CAT, Scent Work, Barn Hunt, Tricks, and she's a therapy dog. My other Lab, Callie is the sweetest dog ever but can be a little hellion. Unlike her big sister, she has destroyed 12 throw rugs, 8 pairs of shoes, the upholstery in my car, a couple of pant legs, and countless toys. But she is coming along. # THINKING OF ELEPHANTS

Most of the time something is on my mind or I think needs to be said, and the editorial largely writes itself. This time I find things complicated because we will be voting in a new board of directors in a few weeks and I am on the slate. I want to be objective, not put the cart before the horse. I do find that there are a few elephants in the room with me so here they are:

- I've served on the board before and I always hate it when the club seems to fall into the Board vs. Other Members mind set. "They don't care." "They don't listen." "It doesn't matter to them." Let's make the problem the enemy and not each other.
- About a year ago I suggested a club mission statement derived from our constitution. Mission statements set a standard and guide decision making and goal setting. I recently rewrote it (no one seemed to be using the old one any way): Muncie Obedience Training Club teaches people to be responsible dog owners and canine companion sports participants, and holds events celebrating dog training. This is what we do, right?
- Members make a membership organization. For others it's important that they get a chance to chat and meet new people. For still others work is a chance to learn and to help others learn to better themselves. Then there are those for whom work is a chance to achieve something, to meet a goal.

- 1-2 pm Beginner Rally: Beginner skills for AKC Rally, Novice Signs, Intermediate/ Advanced signs. Dogs should be able to sit and lie down on cue, stay in a sit and down for 30 seconds from 6 ft. on leash, walk on a loose leash for 20 ft., and be able to work around other working dog/handler teams.
- 2:30-3:30 pm Excellent-Master: Skills for Excellent and Master level, Excellent Signs, Master signs. Dog/Handler teams should be familiar with Novice and Advanced signs and be able to work off leash.

# ANIMAL TRAINING: SUCCESSFUL ANIMAL MANAGEMENT THROUGH POSITIVE REINFORCMENT BY KEN RAMIREZ

This book is a hefty 578 pages long, written by Ken Ramirez as a text book for new trainers at Shedd Aquarium when he was executive vice president of animal care and training there. It contains articles he collected


over the years with permission of the author, as well as what he learned over the years working with a variety of animals. It is a nice reference book for anyone training animals from alpacas to dogs to parrots to zebras using positive reinforcement.


While not specifically a dog training book, although there are some articles on working with dogs, dog trainers and training instructors will find ideas that can be adapted for use with dogs:

- The importance of knowing about the species
- The benefits of record keeping
- Developing trust
- The value of training plans
- Teaching animals to help with their care
- The benefits of variety
- Dealing with aggression
- Problem solving

Ken Ramirez has been a professional trainer for over 40

years working with a variety of species, working with guide dog and law enforcement dog trainers, zoo and aquarium trainers around the world, and conservationists. My own personal favorite story is his training of butterflies for an exhibit in England to fly from one area to another synchronized to music. Ken currently is chief training officer of Karen Pryor Clicker Training.





# **BRAGS & WAGS**


